### TORI MCCLURE

FIRST WOMAN & AMERICAN TO ROW ACROSS THE ATLANTIC PRESIDENT OF SPALDING UNIVERSITY

Tori Murden McClure is an explorer, author and, since 2010, the President of Spalding University in downtown Louisville, Kentucky. During her career, she has worked as a chaplain at a Boston hospital, as the director of a Louisville women's shelter, as a policy assistant in the Louisville Mayor's Office, and as the first full-time employee of the Muhammad Ali Center in Louisville.

Tori is perhaps best-known as the first woman and first American to row a boat solo across the Atlantic Ocean, having accomplished the feat in 1999 after 81 days at sea. A decade earlier, she became the first woman and first American to ski to the geographic South Pole during a 50-day, 750-mile expedition.

She is a former Board Chair of the National Outdoor Leadership School, and she is a former Vice Chair and Interim Chair of the NCAA Board of Governors – the top governing body in collegiate athletics. Under her leadership, Spalding was certified as the World's First Compassionate University.

Tori holds a bachelor's degree from Smith College, a Master of Divinity from Harvard University, a law degree from the University of Louisville and a Master of Fine Arts in writing degree from Spalding. She is author of the memoir, A Pearl in the Storm: How I Found My Heart in the Middle of the Ocean, which details her life and journey across the Atlantic. The book is the basis of a stage musical, called, Row, which made its world premiere at the prestigious Williamstown Theatre Festival in Massachusetts in the summer of 2021.

## JOHN LOWRY

John Lowry is a recognized authority on negotiation through his experience as a lawyer, management consultant, entrepreneur, negotiation coach, and university administrator. He is the author of Negotiation Made Simple, a new book published by HarperCollins in 2023. His results-focused, systematic approach to negotiation has been successfully implemented by thousands of professionals across the United States. John teaches negotiation at the top ranked Straus Institute for Dispute Resolution at Pepperdine University School of Law and in Vanderbilt University's Master's in Management in Health Care program.

John serves as co-founder and principal of Thrivence, LLC, a management consulting firm affiliated with Barge Design Solutions in Nashville, TN. In addition to leading the firm, John counsels clients on strategy, revenue growth, leadership development, and conflict management. He also serves as president of The Lowry Group, LLC ("TLG"). At TLG, he provides negotiation training and coaching for governmental entities, major insurance companies, health care organizations, and other businesses. He writes and speaks extensively on negotiation and is the host of a podcast entitled Negotiation Made Simple.

In 2016, John was selected by Harvard Business School for its Young American Leaders Program. He was also selected for the 2015 class of Leadership Tennessee and is an inductee of the Williamson County (TN) Business Hall of Fame. John earned his bachelor's degree in speech communications from Pepperdine University and master's degree in religion from Abilene Christian University. He received his juris doctorate degree from Southern Methodist University's Dedman School of Law. He has also completed graduate work in dispute resolution at the Straus Institute for Dispute Resolution at Pepperdine University School of Law and in public policy at California State University, Sacramento.

John resides in Nashville, TN with his wife, Melissa, and their three children.



### STEVEN L. BASHAM

LIEUTENANT GENERAL RETIRED B-1, B-2, B-52 BOMBER PILOT DEPUTY COMMANDER OF THE U.S. EUROPEAN COMMAND

Lieutenant General (Retired) Steven L. Basham served more than 36 years in the United States Air Force and in various leadership roles across the Department of Defense.

Most recently, Lt. Gen. Basham was Deputy Commander, United States European Command, Stuttgart, Germany where he oversaw a warfighting headquarters conducting a full range of multidomain operations with more than 85,000 permanent and rotational military personnel in coordination with Allies and Partners to support NATO, deter Russia, enable global operations, and counter trans-national threats. Prior to this, he was Deputy Commander, United States Air Forces Europe-Air Forces Africa.

Lt. Gen. Basham is a decorated bomber pilot with more than 3,400 flying hours in the B-1, B-2, B-52, T-38 and T-37. He holds the honor of being selected as one of the first non-instructor pilots for the B-2 Stealth Bomber program. In addition, he was one of the first four pilots in 1999 to fly the B-2 into combat, flying non-stop from Missouri to Serbia and back, during Operation ALLIED FORCE, earning the Distinguished Flying Cross. He went on to earn three Air Medals for additional flights over Serbia as well as over Iraq. Steve was also awarded the Defense Distinguished Service Medal, third highest medal to be earned for exceptionally meritorious service, along with numerous other awards and decorations.

Lt. Gen. Basham graduated from Western Kentucky University with a degree in Electrical Engineering Technology. He became an officer in 1989 through Officer Training School. He holds four Master of Arts Degrees including Management, Webster University; Strategic Studies, Air Command and Staff College; Strategic Studies, Army War College; and Airpower Art and Science Degree, School of Advanced Air and Space Studies. He is also a graduate of Enterprise Leadership Seminar, Darden School of Business, University of Virginia; Senior Manager Course, Elliott School of International Affairs, George Washington University; Seminar for Executives on Legislative Operations, Georgetown University; Senior Executives in National and International Security, Harvard Kennedy School; Leadership at the Peak, Center for Creative Leadership; and numerous other General Officer programs to include Capstone and Pinnacle courses.

Lt. Gen. Basham completed numerous flying, staff, and command assignments to include Commander, 393rd Bomb Squadron, Whiteman AFB, MO; Chief Combat Plans Division, 607th Air Operations Center, Osan Air Base, South Korea; Vice Wing Commander, 5th Bomb Wing, Minot, ND; Commander, 2nd Bomb Wing, Barksdale AFB, LA. His staff assignments include Joint Staff Assistant Deputy Director, Command, Control and Nuclear Operations, and Deputy Director for Requirements, Pentagon; Director, Pacific Air Forces Strategy, Plans and Programs, Hickam AFB, HI; Chief, Air Force Legislative Liaison, House of Representatives; and Director, Air Force Legislative Liaison, Pentagon.

Most importantly, he has been married to the former Angie Fleenor for 36 years and they are blessed with two beautiful daughters, Sarah and Lauren.

## DR. GARY **RANSDELL**

PRESIDENT/CEO OF THE INSTITUTE FOR SHIPBOARD EDUCATION (ISE) WESTERN KENTUCKY UNIVERSITY PRESIDENT EMERITUS

Gary A. Ransdell spent a 45-year career in various leadership roles in Higher Education. Most recently, he served as President/CEO of the Institute for Shipboard Education (2018-2020) which operates Semester at Sea, a global study abroad program. From 1997 to 2017, Ransdell served as President of Western Kentucky University in Bowling Green, Ky. Over his 20 year tenure, he led a transformation of WKU with two successful capital campaigns (\$304 million in new gifts), \$972 million in capital construction, significant enrollment growth (14,500 to 21,000 students), creation of an Honors College, new Engineering degrees, new doctoral programs, and an internationalization of the undergraduate and graduate experience. Ransdell served as Vice President for Administration and Advancement (1993-1997) and Vice President for Advancement (1987-1993) at Clemson University. From 1981 to 1987 he was the Director of Alumni Relations at Southern Methodist University, and was the Associate Director of Alumni Affairs at WKU from 1978 to 1981. He received a Doctorate of Education degree from Indiana University in 1978, a Master of Public Administration degree from WKU in 1974, and a Bachelor of Arts degree in Mass Communication from WKU in 1973.

Gary Ransdell is currently serving as Chair of the Board for the Arts of Southern Kentucky which operates the Southern Kentucky Performing Arts Center (SKyPAC), Orchestra Kentucky, the Ramsey Theatre Company and BG on Stage. He has also served on the Board of the Louisville Branch of the St. Louis 8th District Federal Reserve Bank (2007-2013, Chair from 2010-2012) Ransdell has been married for 51 years to Julie Bush Ransdell (WKU, 1975).

Graduating from WKU in 1972, Jim became the first in his family, with a BS in Agriculture, it was time for him return to Michigan, but he realized that he loved Bowling Green and didn't want to leave. After working 15 months as an Agronomist with the KY Highway Department, he was offered an opportunity to sell mobile homes at a dealership. Starting with no money, in May 1974 with a bank loan of \$2,500, Jim purchased his first mobile home as a rental property.
